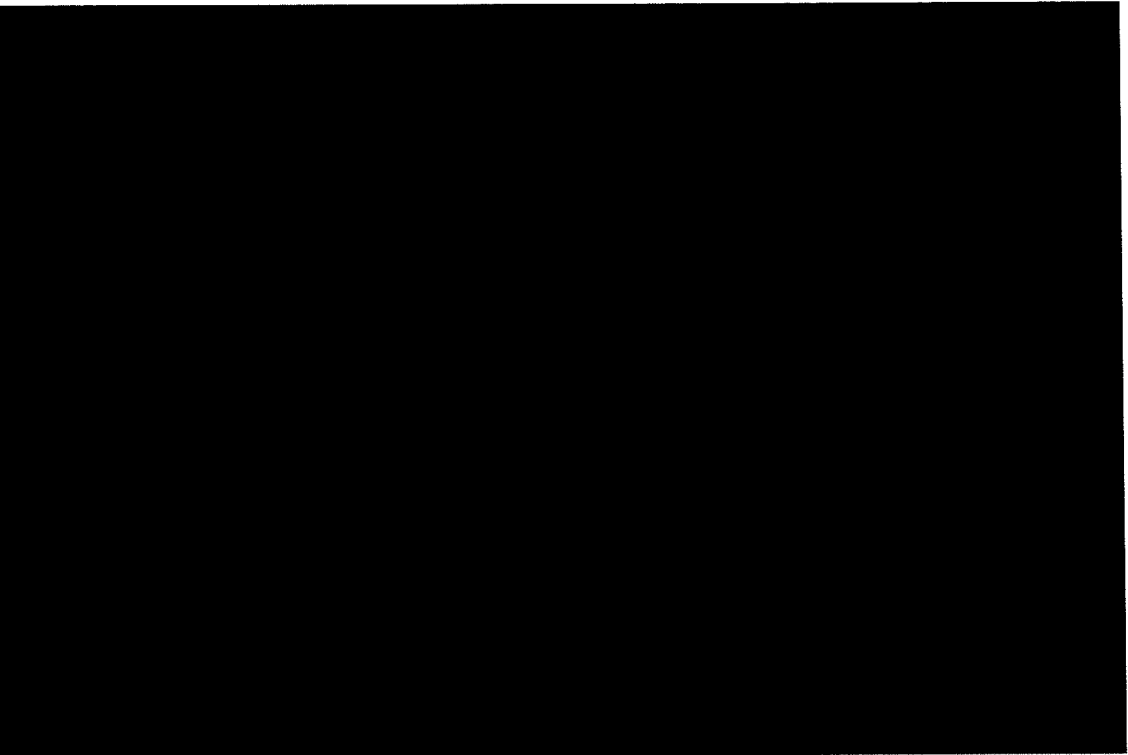

I feel I cannot even write my full feelings in this email as I have reasonable concerns that my emails are being hacked.

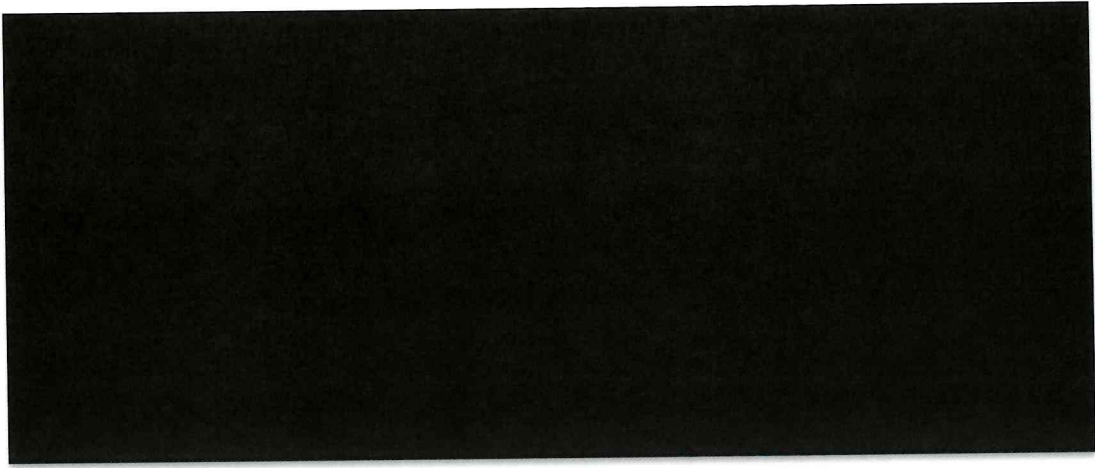

I would be the first to say that the emails will not help the issue in the community as have my opinion on email. They also however state the reason I wanted jumpers - the same reason we brought jumpers in. I understand the emails show our view on uniform - this however is a view the GB are fully aware of and rigorous discussions were held before the purchase of the jumpers. Regardless of this, I fully recognise this will not help the way people who are anti-uniform will feel about wearing jumpers on trips. The bottom line though remains my emails have been taken or hacked. This is a very serious situation.





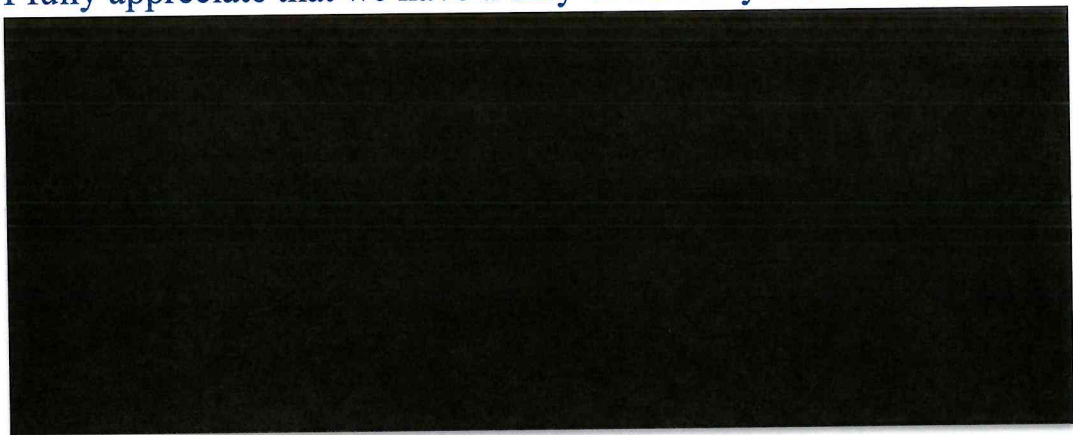
